- 1. - 4. The Board of Directors of the Company, at their meeting held on November 25, 2022, has inter alia accorded approval for a Scheme of Arrangement of Merger by absorption of Hinduja Leyland Finance Limited into the Company. The said Scheme/ Merger is subject to necessary statutory/ regulatory approvals and approval of shareholders and accordingly, no effect has been given in this unaudited financial results.
- Previous quarter/period items are regrouped/reclassified in line with the current quarter/period's presentation, if any.
